## **Rules and Regulations**

\*Please read carefully before you fill out application

Our mission is to select individuals to serve as ambassadors for The City of Wetumpka and Christmas on the Coosa events and activities. The pageant program provides an opportunity for girls to develop knowledge and skills in a fun and memorable manner that will help build character and develop leadership abilities.

Girls who live in Elmore County will be eligible to participate in Christmas on the Coosa Pageants.

### Every division has a limit of 15 contestants

Tiny Miss Christmas on the Coosa (4Years old-Kindergarten)-Pageant Time 9:30am Petite Miss Christmas on the Coosa (1<sup>st</sup>-3<sup>rd</sup> Grades) -Pageant Time 11:30am Little Miss Christmas on the Coosa (4<sup>th</sup> -5<sup>th</sup> Grades) -Pageant Time 1:30pm Junior Miss Christmas on the Coosa (6<sup>th</sup> -8<sup>th</sup> Grades) -Pageant Time 3:30pm Teen Miss Christmas on the Coosa (9<sup>th</sup> -10<sup>th</sup> Grades) -Pageant Time 5:00pm Miss Christmas on the Coosa (11<sup>th</sup> -12<sup>th</sup> Grades) -Pageant Time 7:00pm

Winners from each pageant must return to the last pageant at 6:45pm

\*Mandatory Orientation will be held on Sunday, October 18, 2020. We will send out meeting times once all applications have been received and reviewed. There are numerous changes to the pageant that will be discussed at the orientation meeting.

\*Rehearsals will be held Thursday, November 5, 2020 at 5:30pm and 7:30pm. Parents are not allowed backstage during the pageants.

\*Pageant winners must agree to represent Christmas on the Coosa at all City of Wetumpka and Wetumpka Chamber Christmas events and other events as outlined by The City of Wetumpka and The Christmas on the Coosa Director. Pageant winners must be present to crown the new winner during the 2021 COTC pageants. If unable to attend they will forfeit their title, crown, and prizes.

\*All COTC contestants are asked to participate in the Wetumpka Police Department Christmas Toy Drive by providing an age appropriate gift for boy or girl. Contestants in the Junior, Teen and Miss Divisions are asked to provide a \$20 gift card to their favorite store. WPD will give these to older kids during the Toy Drive.

\*Inappropriate behavior or failure to follow rules during the pageants may result in the <u>immediate</u> disqualification of a participant as deemed necessary by the pageant staff for the integrity of the program. If disqualified, the participant will be asked to leave the event immediately. No refund of fees will be made in case of disqualification.



#### \*Participants will be judged on the following criteria:

K-8<sup>th</sup> Grade- Introduction 25%, Poise/Appearance 25%, On-Stage Question 25%, Punctuality, and Behavior 25% 9<sup>th</sup>-12<sup>th</sup> Grade- Introduction-25%, Poise/Appearance 25%, On Stage Question 40%, Punctuality, and Behavior 10%

## \*Participants will be judged on appearance as follows:

MAKE-UP: Grades K-2- pale lip color ONLY Grades 3-5 - light make-up, pale lip color, NO EYE SHADOW Grades 6-8 - light make-up, pale lip color, LIGHT EYE SHADOW Grades 9-12 - tasteful make-up, NO GLITTER If you have more than the make-up listed above, you will be asked to remove it before going on stage DRESS: Grades K-2 - holiday or heirloom type dress, NO STRAPLESS Grades 3-5 - holiday or party type dress, NO STRAPLESS Grades 6-8 - holiday or party type dress, NO BARE MIDRIFF Grades 9-12 - evening gowns, NO BARE MIDRIFF **No contestant shall have any body art or body piercings except two piercings per ear.** 

Judges will be provided a copy of these rules and will be instructed to deduct points for failure to follow any pageant rule.

On Stage Question: Participants will be provided with a list of questions during orientation. While on stage contestants will draw one question to be answered.

Tickets-**Due to social distancing tickets will be limited to a certain number per family.** Ticket numbers will depend on the number of contestants.

\*Photographs may be taken during the pageant. However, videotaping the pageant is prohibited. The pageant's official photographer, Chrietzberg Photography will have pageant videos available for purchase.

We consider every participant a winner, however, queen, first, second and third runners-up will be named in all pageants. Winners in the photogenic contests, Christmas spirit, and pageant admission ticket sales winners will also be recognized.

A Miss Photogenic winner will be named in each pageant division. Please submit five copies of the same 5x7 picture with your application. Guests can vote for their favorite photograph through intermission for \$1.00 per vote.

**Please email a picture** in the jpg format to <u>cotc@cityofwetumpka.com</u> by October 18<sup>th</sup>. These pictures will be used in the announcement of the contestants for all pageants. This does not have to be the same picture used for Miss Photogenic. It should be a clear close up picture of the contestant.
