- 1. The property that is the subject of this lease is the Martin Luther King, Jr. Recreation Center.
- 2. The landlord tenant that Б the subject shall the pay to be paid in advance for the rental and use of the leased premises from \$_____ 8:00 am to 5:00 pm. The day of 20 . The premises are to be used only during the above date. If the tenant uses the premises at times other than those mentioned above, whether the use is for decorating, setup, or clean-up, there shall be an extra charge of \$300.00, per day.
- 3. Prior to occupation of the premises, the tenant shall pay the landlord the cash sum of \$300.00 as security deposit for the tenant's performance of this lease and for any damages caused to premises by the tenant, his family, visitors, invitees, and/or guests.
